ELIGIBILITY:

1) This Contest, Flex for Life, is open only to legal residents of the United States and Canada (the "Eligibility Area") who are 18 years of age or older at time of entry. The Contest is not open to employees of pediped™ footwear (pediped), their fulfillment, advertising and promotion agencies, or their other representatives or agents, or members of the respective immediate families of those employees, or anyone with whom any of those employees are domiciled.

HOW TO ENTER:

2) This contest begins on March 1<sup>st</sup>, 2008, 12:01 a.m. Pacific Daylight Time (PDT) ("Start Date") and ends on March 31<sup>st</sup>, 2008 11:59 p.m. PST ("End Date") (the "Promotion Period"). Anyone who purchases at least 1 pair of shoes online at [www.pediped.com](http://www.pediped.com) during the promotion period will be automatically entered. Others wishing to enter without purchasing shoes may download a contest entry form at <http://www.pediped.com/contest.aspx>. Fill out all required fields denoted on the entry form and mail, fax or email to pediped Flex for Life at 1191 Center Point Drive, Henderson, NV 89074 ([contest@pediped.com](mailto:contest@pediped.com)) at any time during the Promotion Period.

3) Limit to one (1) contest entry per person or household and per day. Contestants may enter once a day during the Promotion Period. Extra entries will be deleted. All valid entries will be unaffected. Each time someone enters they are assigned one entry with a unique #.

PRIZES:

4) There will be three (3) Grand Prizes granted to three (3) Grand Prize Winners, consisting of a lifetime supply of pediped Flex shoes. A lifetime supply has been deemed to be 16 pairs of shoes, representing 1 pair every 3 months for a period of 4 years. When the grand prize winners are chosen, pediped™ will deliver, via Fed-Ex, 16 pre-selected pairs of shoes for either a boy or a girl, dependent upon the winners preference. There will also be thirty-one (31) Daily Prizes of one (1) pair of pediped Flex™.
